




#### **LOCATION**

St Peter Port House occupies a corner position on the intersection of Sausmarez Street and Union Street, just off The Grange. It therefore sits in a central position in the town centre and is a short walk from the Law Courts, central business district and the main retail pitch. Other occupiers in the vicinity include First Intuition, Grant Thornton, Ravenscroft, Vistra, Trinity Chambers, Sidney Charles and The Guernsey Training Agency.

Long stay public car parking is available at the Odeon car park and additional on street parking is located in the immediate vicinity.





#### **DESCRIPTION**

The available premises is located on the first floor of St Peter Port House. It offers newly refurbished office accommodation which is arranged in an open plan layout with dedicated kitchenette and male and female toilet facilities. There are also two store rooms

It has been fitted with carpet tile flooring, suspended ceiling, LED lighting, air-conditioning, a mixture of floor boxes and perimeter trunking with power and data. By virtue of having fenestration on three elevations, it has excellent levels on natural light.

Although benefiting from its own dedicated WCs, the premises also has use of additional toilet and shower facilities located in the communal areas. There is also onsite car parking for three vehicles within a secure, uncovered, car park.


