LOCATION

The available premises is located along Collings Road, St Peter Port. It therefore occupies an out of town location whilst still being a short drive away from the town centre and the amenities it has to offer.

DESCRIPTION

The available premises is located on the ground floor of a property known as Caroline House.

Currently classified as Public Amenity use class 18: non-residential health/welfare services, the premises has been divided to offer three treatment rooms (one with a store room), a reception area and a WC. The premises benefits from a large window frontage on a public roadway. This provides ample opportunity to display corporate branding and/or goods.

Alternative uses will be considered by the landlord. This may include retail.

Externally, the premises has the benefit of two dedicated onsite car parking spaces which are located directly in front of the unit.
