LOCATION

Oatlands Village is located in the north of the island, in the parish of St Sampson and is approximately 4.5km to the north of St Peter Port's town centre and approximately 2.2km to the south of The Bridge, St Sampson. Access to the site is via Les Gigands Road, just off La Route du Bray which lies to the north of the property.

Other occupiers on the site include Guernsey Goldsmiths, Rebecca's Chocolate, Craft Wise, Wheels & Co, The Kiln, Willows Nursery and Oaty & Joey's.



DESCRIPTION

Unit 1 forms part of Oatlands Village, a popular attraction for both tourists and locals. It benefits from a good levels of footfall and excellent onsite car parking facilities.

The available premises is arranged over a ground and first floor and offers retail accommodation which is well presented and ready to occupy from the Summer 2025. It has a double frontage offering two entrances into the unit, one from the car park and the other from the central courtyard.

The premises has a large window frontage onto the courtyard which provides plenty of opportunity to display goods and/or corporate branding.
