Situated in the heart of St Peter Port's town centre, this ground floor premises offers well-presented office accommodation.






#### **LOCATION**

#### **DESCRIPTION**

Maison Allaire is an attractive period building which has been converted to provide modern office accommodation arranged over ground and three upper floors. It has been finished to a good standard and is predominantly fitted with LED lighting, carpet tiled flooring, raised access flooring, power and data points and under floor heating.

The available accommodation is located on the ground of the building. The office comprises predominantly open plan office accommodation but with a glass partitioned office / meeting room.

Communal toilet facilities are provided on the first floor of the building and and communal kitchenette is on the second floor.

Externally, the ground floor office has the benefit of an allocated car parking space at the front of the building.
