Situated on St Peter Port's High Street, 32 occupies a prime position and offers four levels of accommodation suited for retail purposes.






#### **LOCATION**

No. 32 is situated on the western side of St Peter Port 's High Street where it occupies a prime position on a pedestrianised street where footfall is high. It also sits close to the public car parking located on the piers.

#### **DESCRIPTION**

32 High Street has a prominent window frontage which provides an opportunity for the display of goods or corporate branding. The unit is arranged over four floors and is offered for sale with vacant possession.

The main retail accommodation is at ground level and is well presented. It is fitted with shelving and spotlights, along with a wood effect floor. There is also an air-conditioning system.

On the first floor is a store room, dedicated kitchenette, WC and office. The second and third floors offer further storage.


