The property is prominently positioned on La Grande Rue in St Martin's. The accommodation is located on the ground floor and comprises an open plan office, breakout area and w/c facilities.






LOCATION

The property is prominently positioned on La Grande Rue in St Martin's, on the intersection of La Grande Rue and Rue Maze in the heart of St Martin's Village. As such it lies directly opposite the Community Centre and several businesses including office buildings, estate agents, retail units, supermarkets and petrol stations.

Other occupiers in the vicinity include Marks & Spencer's, Vets4Pets, Cooper Brouard, Ogier's and the Co-op Grande Marche.





DESCRIPTION

The available premises comprises 1,630 sq ft of well presented office space. The accommodation is located on the ground floor, providing open plan office space with a breakout area and w/c facilities with a shower located to the rear of the property. The property also has a smart reception area with bespoke feature lighting.

The accommodation is light and airy and fitted with floor boxes, ceiling mounted lighting, air-conditioning throughout and Cat 6 cabling. All furniture currently in the office is available for any potential tenant by way of separate negotiation.

Redecoration to the interior of the office is soon to be underway. Any tenant wanting to take the space can have input into colour schemes and specification of the works.

ACCOMMODATION

The property provides approximately 1,630 sq ft of office accommodation.

It benefits from 2 onsite car parking spaces to the rear and if required, additional car parking spaces can be rented from Saint's football club, which is just as short walk away. Long stay public parking is also available opposite Valpys which is also closeby.


