LOCATION

19 - 21 Smith Street is located in the heart of St Peter Port, on the northern side of Smith Street. It is therefore situated in close proximity to the High Street, the main financial district and all the amenities of the town centre. The Royal Court Buildings and the Old Government House Hotel are also located nearby.

DESCRIPTION

19-21 Smith Street offers flexible and well presented office accommodation on the second floor of the building. This is accessed from Smith Street by way of a stepped entrance which leads into a communal stairwell.

The available office has a reception area and numerous rooms which are used as offices or meeting rooms. It also has a kitchen and WC. It is generally fitted with carpets, power and lighting. As there are a few entrance / exits into the premises, there is potential to further subdivide this unit. This floor also benefits from sea views from the reception.
