LOCATION

The available premises is situated on Rue de la Cache, St Sampson and forms part of a well established industrial park known as Garenne Park. It lies in close proximity to Landes du Marche and the main arterial routes connecting St Peter Port, St Sampson and the west and south of the Island.

DESCRIPTION

The available unit comprises both a workshop and office accommodation which forms part of a larger building with 14 onsite parking spaces and external areas.



The offices provides direct access to a workshop/industrial unit which has an electrically operated roller shutter door and mezzanine floors which can be removed if required. This unit is served by an independent wc as well as three phase electric.
