

Cambridge House is situated in the heart of Guernsey's financial district. The available premises is located on the ground floor and benefits from 10 on-site parking spaces.






LOCATION

Cambridge House is located in Le Truchot, a popular location in the heart of St Peter Port's financial district, in close proximity to the North Beach Public Car Park and the central retail area.

DESCRIPTION

The available premises is located on the ground floor of the building. It is fully fitted and comprises predominantly an open plan office with one eight person and one ten person board room. The premises has also been fitted with a breakout/kitchen area, meeting room, communications room and a cellular office.

The premises has also offers:-

- Suspended ceiling grids with LED lighting
- Air conditioning
- Raised access flooring with carpet flooring
- On site shower facilities
- Modern WC facilities

Within the building's secure underground car park, the premises has 10 allocated car parking spaces.

The premises is available to rent immediately.




