Cambridge House is situated in the heart of Guernsey's financial district. The available premises is located on the third floor with stunning sea views.






LOCATION

Cambridge House is located in Le Truchot, a popular location in the heart of St Peter Port's financial district, in close proximity to the North Beach Public Car Park and the central retail area.

DESCRIPTION

The available premises is located on the third floor of the building. It is fully fitted and comprises a large open plan office with a welcoming reception area, a ten person board room, three meeting rooms, a kitchen/breakout area and a storage room. It also comes with secure onsite parking for 9 vehicles and an impressive roof terrace. Given its position on the third floor, it offers stunning sea views over Castle Cornet, Herm and Sark.











