44 The Bordage is a takeaway premises in a central location with high levels of potential passing trade. It has the benefit of a garage and store nearby.






LOCATION

No. 44 is situated on The Bordage, St Peter Port, Guernsey, approximately 450m to the south west of St Peter Port's town centre, harbour and central business district.

It sits within close proximity of Trinity Square and the High Street whilst occupying a prominent roadside position along one of the main arterial roads connecting St Peter Port to the southern and western parishes.





DESCRIPTION

The premises is comprises a takeaway arranged over a single floor at ground level which is accessed directly off The Bordage. Given its main road frontage and large windows to the front, an occupier has the opportunity to display goods and/or corporate branding on a busy main road.

The premises is currently split into two distinct areas, with a seating and service counter to the front and kitchen to the rear. There is also a WC.

Detached from the takeaway, and accessed from Pedvin Street, is a garage with a store room at lower ground floor level.





















