

LOCATION

Lefebvre Place is situated towards the upper end of Lefebvre Street, in a highly central location in the heart of St Peter Port, in close proximity to the core retail area. Other occupiers in the vicinity include a mix of restaurants, retail outlets and office occupiers, with the Royal Courts also being close by. Other occupiers in the vicinity include Polygon Serviced Offices, Office of Data Protection Authority, Aspida, the Crown Officers and various law firms.







DESCRIPTION
