


Unit 4, St Martin's Court

St Martin's Court forms part of the Grande Marche Coop in St Martin's Village and offers well-presented retail accommodation with ample onsite car parking.





LOCATION

Forming part of the Channel Islands Coop Grande Marche site on La Route des Camps, St Martin, Unit 4 fronts onto the car park and forms part of St Martin's Village. It therefore lies approximately 3.1km from St Peter Port's High Street.

As it sits opposite a popular supermarket, the available premises benefits from excellent levels of passing trade.



DESCRIPTION

Unit 4 at St Martin's Court is a retail unit on the ground floor. It is a regularly shaped, open plan premises which has been fitted with wood effect flooring, suspended ceiling with recessed lighting and has a large window frontage suitable for the display of goods and/or corporate branding. There is also an accessible WC at the rear of the store.

As it forms part of the same complex as the Grande Marche Coop, there is ample onsite car parking.


