#### **LOCATION**

Ocean House is prominently situated on the North Plantation, almost directly opposite the Crown Pier Car Park. Being positioned along the seafront makes it ideal for allowing retailers and other businesses keen to capitalise on the trade generated from the tourist and cruise ship industry. Other businesses in the vicinity include a number of retailers, restaurants and food outlets. These include Boots, Creaseys, M&S, White Room, Village East, Hook, The Vault and The Boathouse.



#### **DESCRIPTION**

The premises provides well presented retail accommodation on the ground floor of Ocean House. The retail area is open plan and is fitted with wooden flooring, directional lighting and air conditioning. It also includes ancillary storage on the first floor, together with toilet facilities and a small kitchenette.
