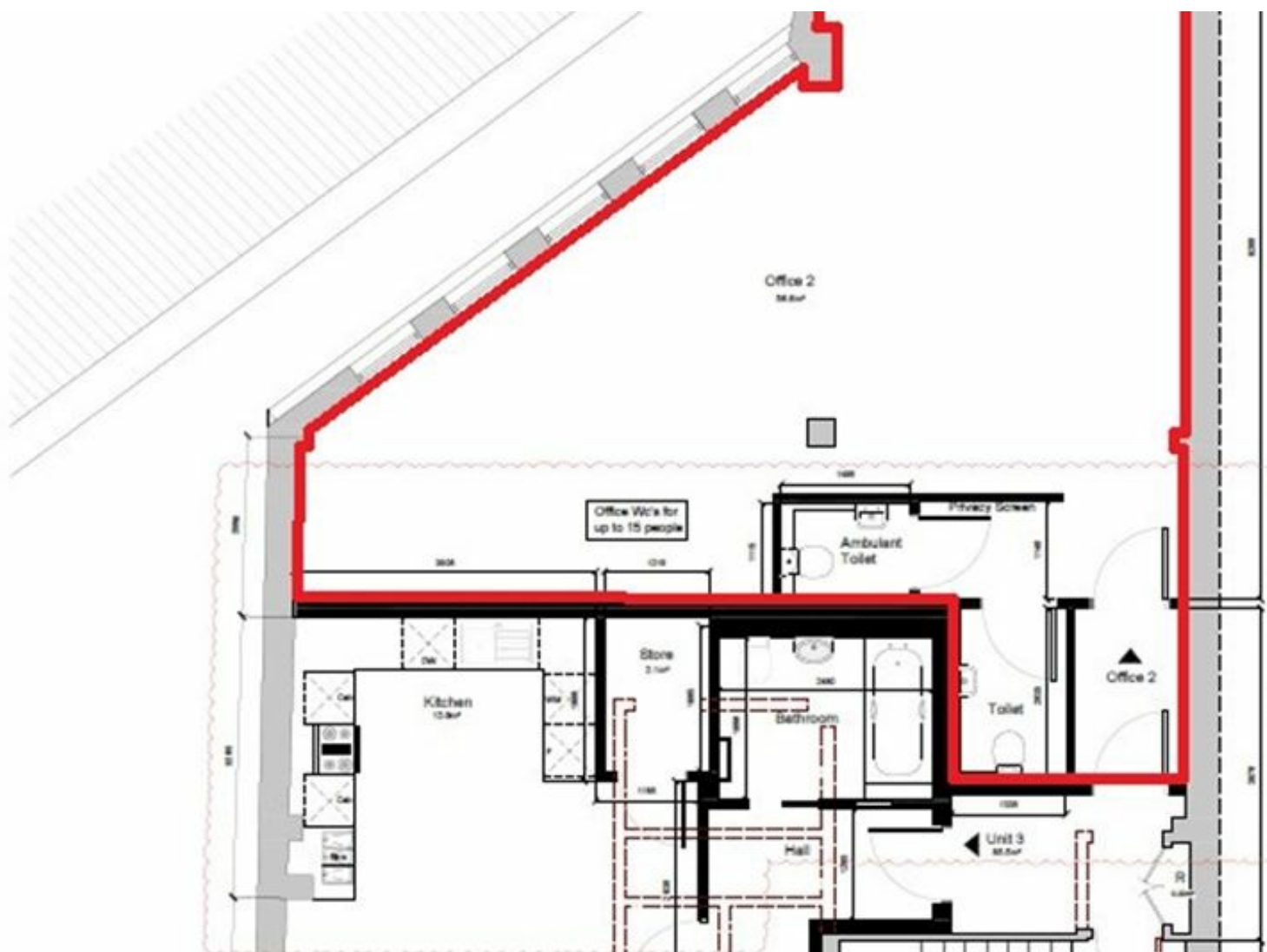

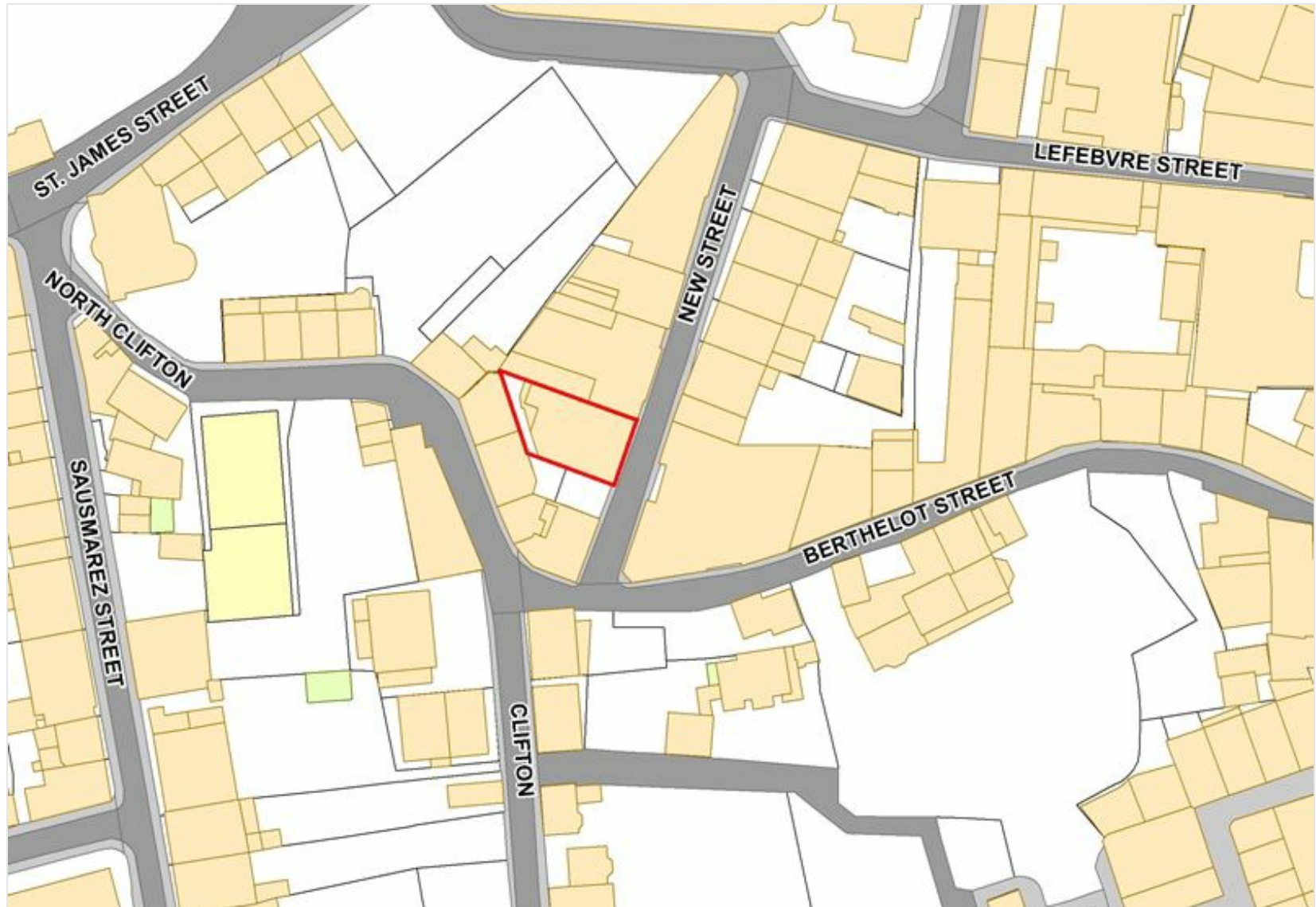

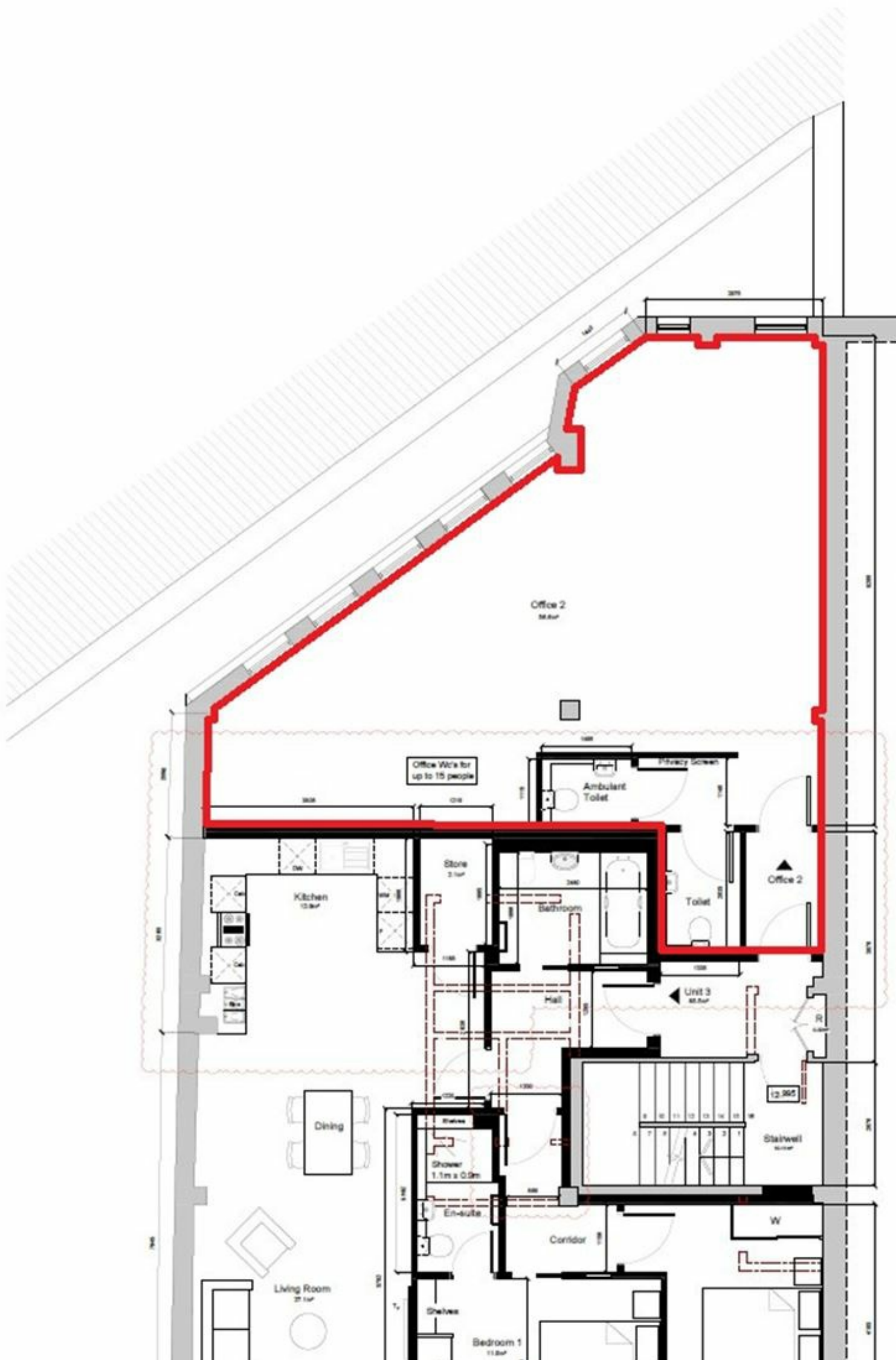
Due to the central location, the premises is in close vicinity to a number of other office occupiers. This includes law firms and those in the financial services sector.

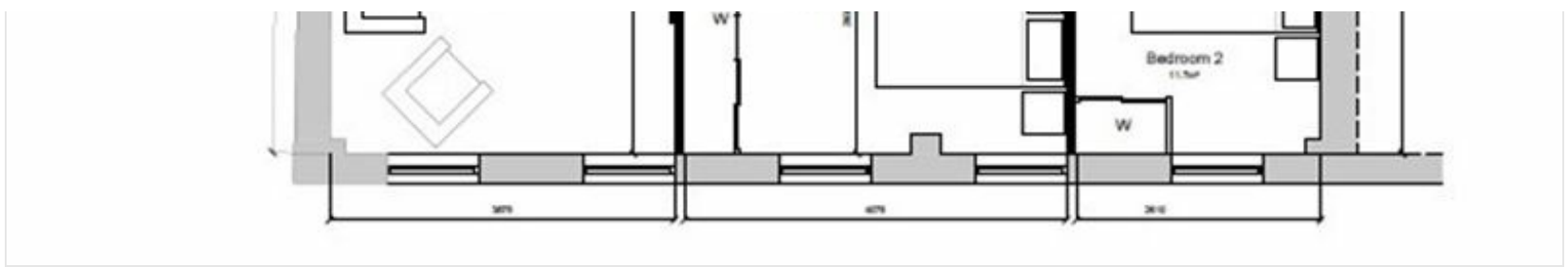


DESCRIPTION
