## LOCATION

16 Commercial Arcade is situated in a central and sought after retail location, on the outer arm of the Commercial Arcade. This is a busy pedestrianised thoroughfare linking Market Square to the High Street and Church Square.

## DESCRIPTION

16 Commercial Arcade is a retail unit set over five floors. This includes a basement and attic.

The ground and first floors are currently being traded from, whereas the basement, second and attic floors are being utilised for ancillary storage / office purposes.

The retail elements are fitted with wood flooring and ceiling hung directional lighting. The property also benefits from a highly visible shop front with large display window which is ideal for the display of goods or corporate branding.


