
Situated in the heart of St Peter Port's town centre, this ground floor office offers well-presented office accommodation with dedicated kitchenette and WCs.

LOCATION

Travel House is situated in the centre of St Peter Port, at the western end of Smith Street.

It occupies a highly central position, in the immediate vicinity of the High Street and the amenities St Peter Port has to offer.

DESCRIPTION

Travel House is an attractive period building which has been converted to provide office accommodation. The available premises is on the ground floor and is accessed via a communal entrance and lobby leading directly off street level.

The premises has been finished to a good standard and is predominantly fitted with suspended ceiling with recessed LED lighting, air conditioning, carpets, raised access flooring, power and data points.

The office comprises predominantly open plan accommodation save for a reception area and a glass partitioned office / meeting room.

There is also a dedicated kitchenette and WC facilities within the premises.
